

**The Detroit Praise Network/WDMK-HD2
Teen Singing Competition
CONTEST RULES**

These rules apply to The Detroit Praise Network Teen Singing Competition Contest (“Contest”) conducted by Beasley Media Group, LLC d/b/a WDMK-HD2 (“Station”). **In addition, the General Contest Rules posted at www.detroitpraisenetwork.com apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

1. HOW TO ENTER

- a. The Contest will begin on September 14, 2020 and end on October 2, 2020.
- b. To enter online, parents or legal guardians of local child performers between the ages of ten (10) and seventeen (17), inclusively, must visit the Contest page at detroitpraisenetwork.com beginning September 14, 2020 at 6:00am Eastern Time (“ET”) and ending on September 25, 2020 at 12:00 pm ET (“Online Entry Period”). Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Limit one (1) entry per eligible child performer or Act (if Act contains multiple performers) during the Online Entry Period regardless if entrant has more than one email address. Multiple entrants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator.
- c. Each entry must include a link to one (1) video clip (“Video Entry”) of at least thirty-seconds (:30) and up to sixty-seconds (:60) showcasing his/her child performing one (1) gospel song (preferably a song played in rotation on the Station) (each an “Act”). The parent/legal guardian will be considered the entrant for this Contest. Entrants must provide a “SHARE” link of their Video Entry in their online entry form. Each entrant must agree to the online submission release in order to submit his or her Video Entry link. When providing a link, it is the entrant’s responsibility to ensure the Video Entry link is set to “public.” Station is not responsible for any Video Entry links that are removed, faulty or disabled after the Video Entry link is submitted.
- d. The Station, in its sole discretion, reserves the right to disqualify any entrant if such entrant’s associated Video Entry or other content contains illegal, indecent, pornographic or sexually explicit content or otherwise offensive material such as graphic violence or if such Video Entry or other content contains any nudity or content deemed at the Station’s discretion to be unsuitable for public display or posting on the Station’s website. Entries that do not comply with these rules will not be eligible for the Contest. Video Entries may be posted on the Station’s website at www.detroitpraisenetwork.com and by submitting a Video Entry, entrant (1) certifies that he or she has all rights necessary to use the images and music contained in their Video Entry including the express permission of every person who appears in or can be heard in the Video Entry, and (2) grants Station permission to post, embed and/or link to their Video Entry on

www.detroitpraisenetwork.com and to use the Video Entry for Contest and other promotional purposes. Stations reserve the right to remove from any website and disqualify any Act if it believes the Video Entry violates the rights of any third party or is otherwise inappropriate for public viewing.

- e. There will be up to a total of one (1) winner selected in this Contest.

2. ELIGIBILITY RESTRICTIONS

- a. This Contest is open to all Station listeners who are eighteen (18) years of age or older as of the date of entry into the Contest, who are legal US residents, who are the parent or legal guardian of a child that is between the ages of ten (10) and seventeen (17) at the time of entry and reside in the Detroit Metro Area, consisting of the following Michigan counties: Lenawee, Monroe, Wayne, Washtenaw, Jackson, Hillsdale, Ingham, Livingston, Oakland, Macomb, St. Clair, Lapeer, Genesee, and Shiawassee; and the following Ohio Counties: Lucas, Fulton, and Williams, except where prohibited by law.
- b. Parent/legal guardian of the winning Act must show proof of residency and guardianship to verify eligibility and must sign a legal guardianship waiver on behalf of the child performer.
- c. Individuals or bands who are represented by an agent, talent agency, or record label are not eligible to participate unless the Station receives written confirmation, in a form acceptable to the Station, that such agency or label representation and any associated commissions or fees are being waived for all purposes of this contest. Under no circumstances will the Station or any party involved be responsible for any fee or commission to any agent, label or other representative of any contestant or participating performer or band.

3. PRIZES

- a. Up to one (1) First Place Prize will be awarded. The First Place Prize consists of one thousand dollars (\$1,000) awarded in the form of a company check issued in the name of the parent or legal guardian who submitted the entry on behalf of the Act. Winner may also be interviewed by Randi Myles from Detroit Praise Network (subject to availability). Approximate Retail Value (“ARV”) of the check portion of the Prize is \$1,000. Randi Myles interview has no cash or other retail value.

No check will be awarded, processed or mailed until winner has claimed the prize at the Station, presented all required documentation, and signed all required releases and tax forms. Checks will then be processed within approximately four (4) to six (6) weeks following confirmation of eligibility and completion of all requisite releases and IRS forms.

- b. Prizes or prize certificates must be claimed as directed by the Station at the time of winning. Failure to claim Prize by the specified time will result in forfeiture of the prize.

It is the winner's sole responsibility to claim the Prize or prize certificate within the timeline provided in these Official Rules.

4. SELECTION OF WINNERS

- a. At approximately 12:00pm ET on September 25, 2020, up to twenty four (24) "Qualifiers" will be selected by a panel of Station judges from all Video Entries received based on the following judging criteria: song choice, entertainment value, creativity and originality of the performing Act in the Video Entry. Parents/legal guardians of Qualifiers will be notified by telephone promptly following selection. **There is no prize associated with being selected as a Qualifier.**

- b. Up to one (1) winning Act will be selected via Station judging and public voting as follows:

The video link of each of the twenty four (24) Qualifiers will be uploaded to the Station website and will be placed on the Contest designated voting page for public voting beginning at 10:00am ET on September 28, 2020 and ending at 10:00am ET on October 2, 2020. On October 2, 2020 at approximately 3:00pm ET, up to one (1) winning performer / Act will be selected by the Station judges with scoring based (i) forty-nine (49%) on the total number of votes received during the voting period; and (ii) fifty-one percent (51%) with the judging criteria described above by the panel of Station judges. Voting will be taken into account but will not be determinative. Winning performer / Act will be announced on the Station and posted on the Station web page located at www.detroitpraisenetwork.com. Parent/legal guardian of the winning performer / Act will also be notified by telephone and/or email promptly following the judging/voting period.

- c. Entrant need not listen to win or be present to win.
- d. If the parent/legal guardian of the winning performer / Act cannot be contacted by 12:00pm ET on Monday, October 5, 2020, an alternate winning Act may be selected at the Station's discretion (time permitting) from all remaining Qualifiers. The winning Act who fails to respond by this deadline is deemed to be waiving their prize claim and their prize will be forfeited.
- e. Decisions of Station management with respect to the Contest are final.

5. CONDITIONS

- a. The Station reserves the right to end any contest or amend these rules upon announcement on air and by publication at www.detroitpraisenetwork.com.
- b. For website contests: By use of the Station's website and by entering this Contest,

entrants agree to the Station's Terms of Service Agreement and to the use of Personal Information as stated in the Privacy Policy located at www.detroitpraisenetwork.com.
